Policy on the processing of personal data pursuant to article 13 of Regulation (EU) 2016/679 (the "Regulation")

This privacy policy describes the methods used by **O.M.F. DEI F.LLI FUMAGALLI S.R.L.** to gather, store and use your personal data through the website <https://www.omffumagalli.it> (the "Website").

Your personal data will be processed in accordance with the principles of correctness, lawfulness and transparency.

1. Data Controller.

The Data Controller of your personal data is **O.M.F. DEI F.LLI FUMAGALLI S.R.L.**, with registered offices in Via Alessandro Volta 20/20A - 24011 - Almè (BG) (the "Controller"). 2. What personal data do we process?

2.1 Navigation data.

The computer systems and software procedures put in place to make this Website function will acquire, during normal operation, certain forms of personal data for which transmission is implicit in the use of Internet communication protocols. This information is not gathered for the purpose of association to specific Data Subjects, but, for its very nature, could allow the identification of the user through the processing of, and association with, data held by third parties.

This category of data includes IP addresses or the domain names of computers used by those who connect to the Website, URI (Uniform Resource Identifier) addresses for the requested resources, the time of the request, the method used to make the request to the server, the size of the file received in response, the numerical code indicating the status of the response provided by the server (successful, error, etc.) and other parameters relating to the operating system and the user's computing environment.

These data are used solely to gather anonymous statistical information regarding the use of the Website and in order to monitor its proper functioning, and are erased after being processed. The data may be used to ascertain responsibility in the event of hypothetical cyber crimes committed to the detriment of the Website.

2.2 Data provided voluntarily by the user.

In order to allow your subscription to the newsletter service and to receive further commercial communications, the Controller processes your email address.

2.3 Cookies.

3. Purposes and legal basis for the processing of your personal data.

This point 3 contains a description of the potential processing purposes pursued by the Controller in accordance with the service requested.

3.1 Registration for newsletters and commercial communications.

The Controller processes your personal data to allow you to subscribe to the newsletter service and to send you newsletters and marketing communications, invitations to trade fairs and/or conferences. In order to send you marketing communications, the Controller requires your express consent when collecting your personal data in accordance with article 6, paragraph 1, letter a) of the Regulation.

3.2 Right to oppose processing and duration of processing

Your email address will be processed until you decide to unsubscribe from further communications by contacting the Controller via the contacts indicated in point 1 above or by clicking on the dedicated link in any communication you receive from the Controller.

3.3 Site Management.

The personal data described in points 2.1 and 2.3 above will also be processed by the Controller for the purpose of managing the Website, including by carrying out anonymous statistical analyses on the use of the Website in order to monitor proper operation and/or to ascertain liability in the event of hypothetical cyber crimes committed to the detriment of the Website. In any case, said data are processed anonymously and are deleted immediately after processing.

The legal basis for processing is the legitimate interest of the Data Controller to ensure the proper use of the Website and to prevent all possible forms of cyber crime, in compliance with article 6, paragraph 1, letter f) of the Regulation. Therefore, your consent is not required.

4. Method and location of processing.

Your personal data will be processed using printed, computer and telecommunication means, in such a manner as to guarantee their security and confidentiality in accordance with the provisions of article 32 of the Regulation.

5. Disclosure and communication of data.

Your personal data will not be disclosed, unless required for compliance with legal requirements or regulations, and/or to fulfil obligations arising from a contractual relationship with the Company.

Your data may be processed by the employees of the Company, who are specifically appointed as authorised processors, in order to fulfil the aforementioned purposes.

Your data may also be processed by third parties who are entrusted with maintenance and development services related to the Website and our computer system for the period of time strictly necessary for the performance of said services, as well as by providers of other outsourced services and by the Company's consultants in Italy.

These figures operate, in certain cases, in full autonomy as separate Data Controllers, and in other cases as Data Processors specifically appointed by the Company.

Furthermore, for the purposes set out in point 3, your personal data are processed and seen by the employees and collaborators of the Company, specifically designated as persons authorised to process said data, in accordance with the various tasks and instructions assigned.

A constantly updated list of said figures is available on request from the headquarters of the Company.

The personal data processed by the Company are not subject to disclosure.

6. Rights guaranteed by legislation.

Pursuant to the Regulation, you have the right to obtain:

- confirmation that your personal data is being processed, as well as access to, among other things, the following information:
 - a) The purposes of processing.
 - b) The categories of personal data concerned.
 - c) The recipients or categories of recipient to whom the personal data have been or will be disclosed, in particular recipients in third countries or international organisations.
 - d) The envisaged period for which the personal data will be stored, or, if not possible, the criteria used to determine that period (art. 15 of the Regulation).
- the rectification of the personal data which concern you, as well as the completion of incomplete personal data (art. 16 of the Regulation).
- the erasure of your personal data in the cases provided for by applicable legislation (art. 17 of the Regulation).
- the restriction of your personal data in the event of the cases provided for by applicable legislation (art. 18 of the Regulation).
- the right to portability, i.e., to receive your personal data in a structured, commonly used and machine-readable format (art. 20 of the Regulation).
- the right to object to processing, in the cases provided for by applicable legislation (art. 21 of the Regulation).
- the right to withdraw consent granted (art. 7 of the Regulation).
